Kadapa District** to surrender their grant-in-aid in the form of surrendering all duly sanctioned aided posts along with aided staff (both teaching and non-teaching) for absorption into Government-According Permission-Orders-Issued.

ORDER:

Decades ago when the concept of providing grant-in-aid by the Government to Private Educational Institutions was initiated, it was envisioned to improve overall educational infrastructure and access to education in the State. Over the years, the education sector has changed drastically. Especially in the recent past, the Government have put in massive efforts for strengthening education particularly with the launching of programmes / schemes such as Nadu-Nedu, Jagananna Vidya Deevena, Jagananna Vasathi Deevena etc. Owing to all such schemes and establishment of more number of Government Institutions, the educational infrastructure especially in the Government sector has improved significantly.

2. Additionally, it has been brought to the notice of the Government that few private aided educational institutions could not run the courses because of very low enrollments and high operational expenses. Furthermore, there is no need to stress any further on effectively utilizing all the available resources in the educational institutions to achieve the objectives of the schemes namely "Jagananna Vidya Deevena" and "Jagananna Vasathi Deevena" for providing scholarships and "Nadu-Nedu" for strengthening educational infrastructure. Also, wherever necessary, it is important to provide autonomy and opportunity to self-sustain for private aided institutions on par with private unaided institutions on the lines of National Education Policy (NEP) 2020 that highlights the need for providing graded autonomy to colleges.

3. Thus, in the interest of public, after careful review of the existing policy of providing grant-in-aid to Private Educational Institutions in the State, vide GO 1st read above, the Government has formulated a policy for takeover of voluntarily willing Private Aided Degree Colleges including minority institutions by the Government.

4. In pursuance of the orders issued by the Government, vide G.O.1st read above, the Commissioner of Collegiate Education, Vijayawada (CCE) has submitted a proposal, vide the reference 2nd cited, for absorption of existing aided staff (both teaching and non-teaching) of **Layola Aided Degree College, Pulivendula, Y.S.R. Kadapa District** wherein the management of the said institution is voluntarily willing to surrender, not the other assets but, all of their duly sanctioned aided posts along with the existing aided teaching and non-teaching staff working in the institution to the Government and the aided staff of the said institution have also given their consent in writing for absorption into Government. Further, the CCE stated that the service details of these aided staff (both teaching and non-teaching) working in the institution have been verified as per the available records; the

details of the grant-in-aid posts, courses and staff of the institution are as shown in the Annexure attached herewith.

5. Accordingly, the Government after careful examination of the proposal hereby accept the request of the management of the institution to surrender their grant-in-aid in the form of surrendering all of their duly sanctioned aided posts and existing aided staff into the Government. Also, the Government hereby accord permission to the CCE to absorb the aided staff of the institution into Government Educational Institutions through a transparent web counselling process.

6. In this regard, the CCE is also directed to take further necessary action immediately to complete the process of takeover of all the duly sanctioned aided posts of **Layola Aided Degree College, Pulivendula, Y.S.R. Kadapa District** admitted into grant-in-aid till date and to absorb the existing aided staff of the institution (details as annexed herewith) into Government Educational Institutions subject to Special Service Rules to be issued separately and other terms and conditions as detailed below:

- a) The process of such takeover of grant-in-aid posts and absorption of the existing aided staff of the institution shall be as per the policy detailed vide G.O.1st read above;
- b) The Special Service Rules to be issued separately in this regard shall be binding on such aided staff who are willing to be absorbed into Government as the absorption is based on their willingness to do so;
- c) Consequent to absorption of the aided staff into Government Educational Institutions, from the date of absorption of the aided staff into Government, all such aided staff shall be deemed to have been appointed by transfer into the Government and their salary shall be paid duly extending other benefits such as GPF/CPS, APGLI, LTC, EHS etc. suitably as per their entitlement on par with other Government Staff;
- d) From the date of issuance of this order, all the duly sanctioned posts under teaching and non-teaching categories admitted into grant-in-aid so far for the institution shall stand surrendered to the Government for all practical purposes;
- e) Further, all the duly sanctioned vacant aided posts under teaching and non-teaching categories for the institution till date shall stand abolished except the posts covered by orders of the Hon'ble Courts as on the date of issuance of this order;
- f) Furthermore, all the other duly sanctioned aided posts under both teaching and non-teaching categories will stand abolished as and when the incumbent staff in the aided post exits from service due to his/her retirement including voluntary, resignation, demise or any other reason.;
- g) All the pending enquiries and disciplinary or other legal proceedings against the management or the aided staff of the said institution shall continue;
- h) Thereby, the grant-in-aid shall be withdrawn completely for the institution and management of the said Private Aided Educational Institution shall run the institution and all sections / courses as Private Unaided Educational Institution abiding by relevant rules and regulations issued by the Government from time to time;
- i) If the said institution has received any grant from the Central or State Governments or their instrumentalities, any asset created with such grants shall not be disposed of / used for the purposes other than for which it was granted without prior approval of the Government;
- j) If the said institution has been allotted any land by the Government either free of cost or at a concession rate or even on payment of full market value, such land shall not be disposed of / used for the purposes other than for which it was allotted without prior approval of the Government;

- k) If the said institution has got any other lands / assets donated by philanthropists or trusts or other organizations, such land / asset shall not be disposed of / used for the purposes other than for which it was donated without prior approval of the Government;
- l) Further, the students will continue pursuing their studies in the same Private Unaided Educational Institution and the higher fee being charged by the institution will be fully reimbursed to all the eligible students under Jagananna Vidya Deevena Scheme implying that the students continuing their studies in the institution will not be subjected to any extra financial burden;
- m) Furthermore, to curb malpractices, conduct fair and merit based admissions in a transparent basis, the Government has introduced Online Admission Module for Degree Colleges (OAMDC) portal for admission into Degree Colleges across the state from the AY 2020-21 in the larger interest and welfare of the student community. So, the students desirous of getting admission into first year of any UG/PG course in the Institution shall apply through the portal for the AY 2021-22 for which the admissions schedule will be issued shortly;
- n) Additionally, the CCE shall accommodate any existing student of the said institution into any other Degree College of the student's choice only if the student wants to migrate to a Government Degree College or any other Private Degree College in the State;

7. In this regard, the Commissioner of Collegiate Education, the Secretary of AP State Council of Higher Education, the Registrar of the concerned affiliating University, the Secretary of A.P. Higher Education Regulatory and Monitoring Commission and Social Welfare Department shall take further necessary action with respect to takeover of the aided posts and the aided staff, admissions, affiliations, fee fixation and scholarships respectively.



5. Accordingly, the Government after careful examination of the proposal hereby accept the request of the management of the institution to surrender their grant-in-aid in the form of surrendering all of their duly sanctioned aided posts and existing aided staff into the Government. Also, the Government hereby accord permission to the CCE to absorb the aided staff of the institution into Government Educational Institutions through a transparent web counselling process.

6. In this regard, the CCE is also directed to take further necessary action immediately to complete the process of takeover of all the duly sanctioned aided posts of Layola Aided Degree College, Pulivendula, Y.S.R. Kadapa District admitted into grant-in-aid till date and to absorb the existing aided staff of the institution (details as annexed herewith) into Government Educational Institutions subject to Special Service Rules to be issued separately and other terms and conditions as detailed below:

- a) The process of such takeover of grant-in-aid posts and absorption of the existing aided staff of the institution shall be as per the policy detailed vide G.O.1st read above;
- b) The Special Service Rules to be issued separately in this regard shall be binding on such aided staff who are willing to be absorbed into Government as the absorption is based on their willingness to do so;
- c) Consequent to absorption of the aided staff into Government Educational Institutions, from the date of absorption of the aided staff into Government, all such aided staff shall be deemed to have been appointed by transfer into the Government and their salary shall be paid duly extending other benefits such as GPF/CPS, APGLI, LTC, EHS etc. suitably as per their entitlement on par with other Government Staff;
- d) From the date of issuance of this order, all the duly sanctioned posts under teaching and non-teaching categories admitted into grant-in-aid so far for the institution shall stand surrendered to the Government for all practical purposes;
- e) Further, all the duly sanctioned vacant aided posts under teaching and non-teaching categories for the institution till date shall stand abolished except the posts covered by orders of the Hon'ble Courts as on the date of issuance of this order;
- f) Furthermore, all the other duly sanctioned aided posts under both teaching and non-teaching categories will stand abolished as and when the incumbent staff in the aided post exits from service due to his/her retirement including voluntary, resignation, demise or any other reason.;
- g) All the pending enquiries and disciplinary or other legal proceedings against the management or the aided staff of the said Institution shall continue;
- h) Thereby, the grant-in-aid shall be withdrawn completely for the institution and management of the said Private Aided Educational Institution shall run the Institution and all sections / courses as Private Unaided Educational Institution abiding by relevant rules and regulations issued by the Government from time to time;

- k) If the said institution has got any other lands / assets donated by philanthropists or trusts or other organizations, such land / asset shall not be disposed of / used for the purposes other than for which it was donated without prior approval of the Government;
- l) Further, the students will continue pursuing their studies in the same Private Unaided Educational Institution and the higher fee being charged by the institution will be fully reimbursed to all the eligible students under Jagannanna Vidya Deevana Scheme implying that the students continuing their studies in the institution will not be subjected to any extra financial burden;

In pursuance of the orders issued in the references cited and in continuation
of the instructions issued in the reference 4th cited, the Principals of Government
Degree Colleges in the state are hereby instructed to scrupulously follow the
following guidelines with regard to engaging Guest Faculties from the academic
year 2022-23 without disturbing the existing guest faculties working in their
College.

Guidelines:-

- 1) To engage Guest Faculty in the respective subject against vacant sanctioned
posts (excluding lecturers working on OD basis, deputations, redeployed, contract
and PTLs working on Court cases).
- 2) Guest faculty should be engaged if there is a spillover workload of
minimum of 10 hours per week.
- 3) Where there is no sanctioned post, engage the guest faculty by paying the
honorarium from the internal resources of the college subject to sufficient work
load in the subject.

Qualifications:-

- 1) Candidates with 2nd class PG in the subject concerned with not less than 55%
of Marks.
- 2) Candidates who passed National Eligibility Test (NET) conducted by UGC/CSIR
would be given 1st preference and SET/SLET conducted by the Government of
AP shall be given preference invariably.
- 3) NET/SET & SLET is exempted who have PhD in concerned discipline.
- 4) The existing guest faculties working in the colleges have to improve their
qualifications, if they are working without requisite qualifications as prescribed.

Age:-

Must have been within the age limit as per the provisions in AP Educational
Service Rules on the date of engagement as Guest Faculty in Government Degree
College.

(P.T.O)

Selection of Guest Faculty:-

- 1) The Principal of the College shall call for the applications for engaging Guest Faculty at the beginning of the academic year or as and when vacancies arises duly following the requirement of the work load of the subject concerned.
- 2) The Principal shall constitute selection committee consisting of the following members:
 - 1) Principal of the college,
 - 2) Incharge of the subject department
 - 3) Subject expert from same college or neighbouring college,
- 3) The Selection Committee shall take a demo class in the class room from all applicants in the subject and take feedback from the students and engage the Guest Faculty on merit cum seniority basis.

Payment of remuneration:-

The Guest Faculty engaged for Government Degree College would be paid remuneration @ Rs.400/- per hour subject to maximum of Rs.28,000/- PM vide G.O.Rt.No.157, HE Dept Dated:17.10.2022 communicated in CCE's Procs. Rc.No.121/Ser.II/2016, dated:27.10.2022 w.e.f.01.11.2022.

Period:-

The engagement of Guest faculty shall be made for a maximum period of ten (10) months in an academic year. However, the engagement gets terminated at the end of the academic year as per the university calendar for affiliated colleges. In case of Autonomous colleges, their Academic Calendar may be taken into consideration.

In view of the above, the Principals of Government Degree Colleges in the State are hereby instructed to engage the guest faculties from the academic year 2022-23. Any deviation in the matter will be viewed seriously, the Principal alone will be held responsible.
