# RULES AND REGULATIONS

NAME OF THE ASSOCIATION : THE ALUMNI ASSOCIATION.  
STSN GOVT. DEGREE COLLEGE, KADIRI

LOCATION : D NO 1-1189-83D, NGO COLONY, KADIRI -515591  
Sri Sathyasai District. Andhra Pradesh.

1. **MEMBERSHIP** : The person who wants to enroll as members in the society, he has to be paid Rs. 100/- towards membership and also to be paid Rs. 100/- towards admission fee. The person who fails to renew his membership before the end of the three succeeding months, automatically ceases to be a member, No member shall be entitled to vote whose subscription shall have been in arrear for a period exceeding three months.

## 2. **GENERAL BODY AND ITS FUNCTIONS:**

- i) To elect Executive Body or Managing Committee
- ii) To pass budget for ensuing year and approve the expenditure statement of the previous year
- iii) To approve the report of the activities of the society
- iv) To appoint an Auditor.

## 3. **EXECUTIVE BODY** :

The executive body shall consist of members 7 – **(SEVEN)**, which the President, Secretary and Treasurer elected by the General Body to have over all supervision over the day to day administration;

## 4. **MEETINGS** :

- i) The General Body shall meet once in a year in the month of and the elections for the general body shall be held conducted every three years to elect office bearers;
- ii) Extra-Ordinary meetings of the General Body may be convened any time when called for by the Executive body within ten days' notice to all members
- iii) The Executive Body will meet once in a month or earlier if there is need for it.

5. **QUORUM:**Special Resolution means, resolution passed by a majority of the total members of the society and not less than three-fifths (3/5) of the members present and voting in a meeting, of which not less than fourteen clear days' notice, exclusive of the date of dispatch of the notice and the date of meeting, specifying the intention to propose the resolution as special resolution, has been duly given.

6. **SUE OR SUED:**Officer' includes any director, Manager, treasurer, trustee secretary, member of the Committee, or any person appointed by a society to sue and be sued on its behalf and any other person empowered under the rules or the bye law to give directions in regard to the business of a society.

**8. DUTIES OF OFFICE BEARERS :**

i) **PRESIDENT :**The President shall preside all the meetings of the General Body, Governing Body and Sub-Committee. He shall have the rights to call for emergency meeting transaction of the urgent matters if any. He can sanction expenditure to the extent of Rs. 1,000/- at time in a year subsequent sanction in Governing Body.

ii) **VICE PRESIDENT:**In the absence of the President, he shall perform the function of the President

iii) **SECRETARY:**The Secretary shall be Chief Executive in-charge of the Association. He shall be the correspondent. He shall conduct meetings of the General Body. He shall prepare the agenda for the meetings in consultation with the President. He shall maintain the minutes of the proceedings of all the meetings. He shall carry out the resolution passed by the General Body. He has to place before the Governing Body every year, the revised budget of the academic year. He shall maintain all the Registers and Accounts of the Association. He can sanction expenditure to the extent of Rs. 500/- at a time in a year subject to the subsequent sanction of the Governing Body. He shall look after the day to day administration of the association.

iv) **JOINT SECRETARY:**He shall assists the Secretary.

- v. **TREASURER:**The Treasurer shall be the Chief Custodian funds of the society. He shall be in-charge of all cash and finance of the society. He shall operate the Bank account of the Society jointly with the Secretary. He shall maintain such account as they are prescribed by the Governing Body.
- 9 a) **SUIT:** The association may sue in the name of the Association.
- b) **BANK ACCOUNT:**The funds of the Society shall be operated by the Secretary and Treasurer only. **FUNDS:** The funds of the Society shall be deposited with an approved Nationalized / rural Banks or in a Post Office. The funds of the Society shall be spent only for the attainment of the objects of the Society and no portion thereof shall be paid or transferred directly or indirectly to any of its members through any means.
10. **AMENDMENT:** No amendment or alteration unless it is voted by 3/5 of the members present at a meeting and confirmed by the '3/5 of the members present at a second special meeting convened by the Governing Body at an interval of one month after the meeting.
11. **DISSOLUTION OR WINDING – UP:** Any number not less than 3/5<sup>th</sup> of the members of the Society may determined that it shall be dissolved, if upon the dissolution of the society, there shall be dissolved, if upon the dissolution of the society, there shall remain after the satisfaction of all its debts and liabilities – any property what so ever, the same shall be transferred to some other having similar aims and objects but shall not be paid or distributed among the members of the Society. In case this Association has to be winding up it will be done as per Rules of the Andhra Pradesh Societies Registration Act No. 35 of 2001.


